To be raced Little Brown Jug Week in Delaware Ohio

**Stallion Subscription is due May 15, 2018**

Subscribe now to make his progeny eligible to over \$750,000 worth of stakes as a 2 and 3-year-old at Delaware, Ohio

**Eligibility:** Foals of 2017 by stallions registered with the Ohio State Racing Commission for the year of conception (2016) providing the Stallion subscription is made May 15, 2018 to establish for his foals to these Championship events.

**Stallion Subscription:** Due May 15, 2018. One half of the stud fee charged for the year of conception (2016), minimum of \$300. Stallions must have registered with the Ohio State Racing Commission and must have stood in Ohio the entire breeding season of the year the colt or filly was conceived. This year's payment will cover foals for 2017 to be raced at Delaware, Ohio as 2-year-olds in 2019, and 3-year-olds in 2020.

**Payment of the Stallion Subscription:** Will allow owners of yearlings to be sold in 2018 that were conceived in 2016 to advertise eligibility to the OHIO BREEDERS CHAMPIONSHIPS and use the championships logo in advertising.

**Conditions for Delaware Races Under the Ohio Fair Fund Law:**

1. Eligibility: All Ohio-bred colts, fillies & geldings that are sired by a stallion registered with the Ohio State Racing Commission and upon which the stallion subscription has been made to the Delaware County Fair.
2. The above colt, fillies & gelding's races will be conducted by the Delaware County Fair to create an OHIO BREEDERS CHAMPIONSHIPS series. All stallion fees collected by the Delaware County Fair are to enrich these races and will be added to the purse. There will be no deduction for promotional expenses. The Stallion subscription will be added equally among the races for 2-year old and 3-year old colts, fillies & geldings in 2019 and 2020.
3. OWNER NOMINATION PRIVILEGE: If an owner has any foal by a stallion properly registered for service in Ohio, but not subscribed to the OHIO BREEDERS CHAMPIONSHIPS, the owner shall have the privilege of nomination the colt, filly or gelding when the first nominating payment comes due March 15<sup>th</sup>, by paying a supplementary fee of \$300 in addition to the nominating fee. This supplementary payment will make the colt, filly or gelding eligible to a future OHIO BREEDERS CHAMPIONSHIPS races and will be added to the purse distribution in the year it is received.
4. Nominating fee of \$300 will be due on March 15<sup>th</sup>. Aged races nominating fee is \$100. By Mar 15.
5. Starting fee becomes due at time of declaration and must be paid one hour prior to post time as follows: 2 and 3-year-old championships events ..... \$750, aged events-----\$

6. Horse must be declared in at 10 am three days prior to the race, Sunday included.
7. All of the events will be raced on the one heat plan. If more than 10 horses declare in the field will be divided and the purse will be divided in equal shares. Purses will be divided equally with money division of 50-25-12-8-5% each heat.
8. \$4,000 will be added to each of the eight events in addition to the stallion subscription, nomination fee, starting fee, the Ohio Fair Fund Grant monies.
9. This track is licensed by the Ohio State Racing commission and operates under the rules of The Ohio State Racing commission in conjunction with The United States Trotting Association. The Delaware County Fair shall have final decision on all matters pertaining to racing of these stakes.
10. All nominating and starting fees should be made payable to The Delaware County Fair and mailed to Tom Wright, PO Box 1560, Powell, Ohio 43065.
