1. **ELIGIBILITY:** All Ohio-bred colts, geldings & fillies that are sired by a stallion registered with the OSRC and upon which the stallion subscription has been made to the Delaware County Fair. A list of eligible stallions is shown on the facing page of this entry blank.

2. The above colt, gelding and filly races will be conducted by the Delaware County Fair to create an OHIO BREEDERS' CHAMPIONSHIPS series. All stallion fees collected are to enrich these races and will be added to the purse. There will be no deduction for promotional expenses. The stallion subscription will be added equally among the races for 2-year- and 3-year old colts and fillies in 2012 and 2013.

OWNER NOMINATION PRIVILEGE: If an owner has any foal by a stallion properly registered for service in Ohio but not subscribed to the Ohio Breeders' Championships, the owner shall have the privilege of nominating the colt, gelding or filly when the first nominating payment comes due Feb. 15, 2012, by paying a supplementary fee of \$300.00 in addition to the nominating fee. This supplementary payment will make the colt, gelding or filly eligible to all future Ohio Breeders' Championship races and will be added to the purse distribution in the year it is received.

3. Nomination fee of \$200.00 will be due on Feb.15.

4. Sustaining fee of \$200.00 due April 15.

5. Starting fee becomes due at time of declaration and must be paid one hour prior to post time as follows:

2 and 3 year old championship events.....\$750

6. Horses must be declared in at 10 a.m. three days prior to the race — Sunday included.

7. All of the events will be raced on the two-heat plan. There will be no third heat if two heat winners prevail. The horse standing best in the summary will receive the trophy. In the event of a tie the horse winning the fastest heat will receive the trophy. Purses will be divided equally into two parts with money division 45-25-15-10-5% each heat.

8. \$4,000 will be added to each of the 8 events, in addition to the stallion subscription, the entry fee, the declaration fee and the Ohio Fair Fund grant.

9. NOTICE: U.S.T.A. Rule 11, Section 3 provides: "Failure to make any payment required by the conditions constitutes an automatic withdrawal from the event." The Delaware County Fair will construe payment to require that cash or check duly honored upon presentation be received at the time specified in U.S.T.A.

Rule 12, Section 4. If a check is not duly honored upon presentation, the horse becomes ineligible to race, or if it races, to participate in the purse.

10. The track reserves the right to race any or all of these events as single dashes. In addition the track reserves the right to race elimination heats as divisions for an equal amount of the purse.

11. This track is licensed by The State of Ohio Racing Commission and operates under the rules of The Ohio State Racing Commission in conjunction with The United States Trotting Association. The Delaware County Fair shall have the final decision on all matters pertaining to the racing of these stakes.
